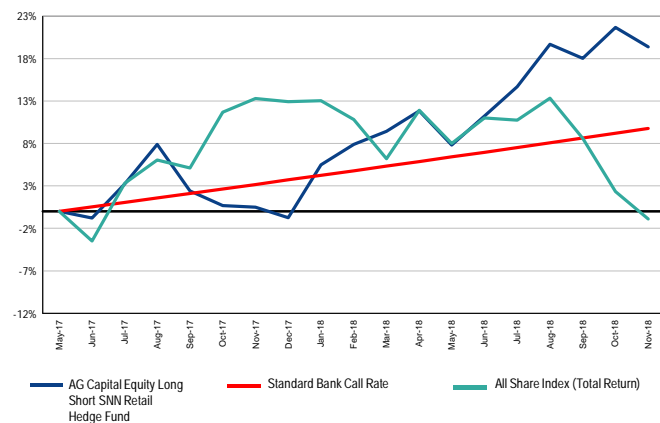
Objective & Investment Policy

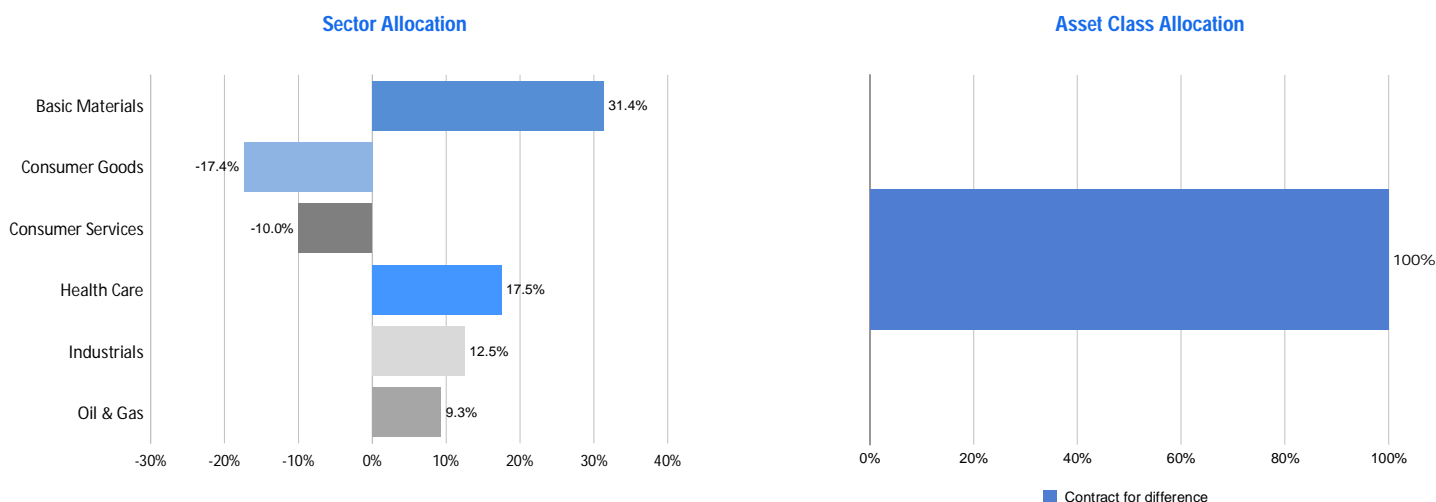
Portfolio Valuation & Transaction Cut-Off

*Total Expense Ratio & Transaction Costs
